Handling differences of views: In preaching, sometimes there are differences of views between various religious groups. In facing these challenges, preachers must strive to develop communication skills, adapt to the local environment, and build tolerance and diversity within the community. Da'wah in Indonesia has several challenges, such as a wrong understanding of Islam, limited knowledge of other religions, social and economic injustice, security challenges, and lack of access to media and technology (Thaib, 2020). To overcome these challenges, preachers can make several efforts, such as strengthening knowledge and understanding of Islamic teachings, building interreligious dialogue and mutual understanding, using social media and technology to reach a wider audience, participating in social and community activities, and establishing good relations with security forces to overcome security problems.

Strengthen understanding and skills in conducting da'wah that is inclusive and responsive

To strengthen understanding and skills in conducting da'wah is inclusive and responsive in Indonesia's pluralism context, several steps can be taken, including Understanding the social and cultural context of the community where da'wah is carried out (Alifuddin et al., 2021). Responding to the threat of radicalism and extremism that can threaten peace

## 4 Conclusion
